Business License Operating Conditions LIC415839, Mowney INC. Tobacco Dealer License

- The licensee agrees that 'No Trespassing' and 'No Loitering' signs will be clearly posted on the exterior of the business. Staff will immediately ask people that are observed loitering anywhere on the premises to leave. If loitering activity persists, staff will call 911 and request police assistance to alleviate the loitering activity.
- 2. The licensee agrees to actively address security concerns to include loitering, drug activity and trespassing. The licensee will develop a written policy for trespassing complete with pictures of trespassed people and this policy will be submitted at the time of signing.
- 3. The licensee shall take all necessary and prudent steps to avoid violent incidents from occurring at their establishment by assessing customers' behaviors and removing any customer who acts in a belligerent, loud or otherwise disruptive manner. If any criminal activity is observed, security must escort the customer from the premises and request Minneapolis Police assistance.
- 4. The licensee agrees that any vehicle parked in their dedicated parking spaces whose occupants are not making a purchase from the business shall be trespassed from the location.
- 5. The licensee will hire an employee whose primary duties will be to deal with litter collection and removal, including areas surrounding the business such as sidewalks, gutters and landscaping, during all hours of operation. Another core duty will be monitoring and enforcing the no loitering/trespassing policies during all hours of operation.
- 6. The licensee shall introduce a schedule that will show when cleaning was done and which employee cleaned.
- 7. The licensee agrees to submit and follow a business plan during all operation hours.
- 8. The licensee agrees to provide a uniform that clearly distinguishes employees from the general public.
- 9. The licensee is prohibited from allowing any consumption of alcoholic beverage within the establishment
- 10. The business agrees not to sell items which are commonly used by drug users and drug dealers. These items include glass pipes specifically with roses, Brillo Pads or Chore Boy products, and single razor blades. The business will also agree not to supply matches to non-tobacco customers.
- 11. Dedicated security staff shall assist in crowd dispersal for at least one-half hour after closing of the establishment to prevent loitering.

I have read and understand the conditions listed above. I agree with the conditions and understand that failure on our part or on the part of my company or employees to adhere to these conditions, may be cause for future adverse license action, including the suspension, revocation, or denial of the renewal of the LIC415839, Mowney INC dba High 5 Tobacco. These conditions will be effective for the duration the license operates at these premises, unless otherwise amended by the City Council of Minneapolis.
